### **Remote Patient Monitoring Devices**

#### **Benefits**

- Used to help manage and personalize your medications and plan of care.
- All devices and monthly blood glucose supplies are included in the program for no additional cost.
- All readings sent electronically to our office.
- Use your devices any time.
  Readings are not monitored by our staff in real time.

## Eligibility & Cost of CCM and Remote Monitoring

- Have 1 chronic condition for RPM, and 2 chronic conditions for CCM.
- Medicare claim filed from Dr. Deucher's office monthly. Claims subject to annual deductible.
- Coinsurance \$0 to \$30 per month per program depending on your insurance plan.



#### **Chronic Care Management**

Dr. Deucher would like to partner with you to keep you as healthy as possible in between office visits. If you have Medicare, and two or more chronic conditions, Dr. Deucher requests you be enrolled in St. Luke's Medical Chronic Care Management program. Services such as monthly check-ins and ready access to your care team will provide the ongoing and proactive care you and Dr. Deucher need to prevent chronic illness from getting the upper hand.

#### **Benefits**

- A care team who works with you to support your health plan and preventive care needs in between office visits.
- Regularly scheduled telehealth (your preference phone or email) appointments with Dr. Deucher's nurse who will provide you with the information and tools you need to stay on top of your health needs, goals, and concerns.
- Counseling and education for diet, medication and monitoring for your specific chronic health conditions.
- Timely and accurate medication refills.
- Management of medical care between providers and follow-up medical coordination after emergency room visits or hospitalizations.

#### **Agreement to Receive Chronic Care Management Services**

As a patient with two or more chronic conditions, you may benefit from a new program providing chronic care management (CCM) services to Medicare patients. CCM services include:

- Care management for chronic conditions, including systematic assessment of your health care needs, timely scheduling of preventive care services, and medication review, oversight, and medication refills.
- Access to your care team 24-hours-a-day, 7-days-a-week, including non-face-to-face access such as telephone, email, and secure messages.
- Successive routine appointments with a designated member of your care team.
- Creation of a comprehensive plan of care for your health issues.
- Management of care transition among health care providers and settings, including referrals to other clinicians, follow-up after and emergency department visit, and follow-up after discharges from hospitals, skilled nursing facilities or other health care facilities.
- Medical coordination with home and community based clinical service providers.

#### **Agreement to Remote Patient Monitoring Services**

As a patient with one or more chronic conditions, you may benefit from a new program Remote Patient Monitor (RPM) services to Medicare patients. RPM services include:

- Access to devices including blood pressure cuff, blood glucose monitoring, body weight scale, pulse oximetry, and thermometer. Equipment provided for no cost including blood glucose testing strips and supplies.
- Readings from devices are transmitted thru the internet to your health care team.
- The RPM program is not monitored in real time, readings are reviewed weekly by your care team.
- RPM program is not a replacement for emergency services. Call 9-1-1 for medical emergencies.

#### **Your Rights**

- As part of the CCM and or RPM services, you will receive a copy of your comprehensive plan of care and remote monitoring devices will be mailed to your home.
- You have the right to stop the CCM and or RPM services at any time, effective at the end of the calendar month. Please contact our practice at (910) 725-0809 to revoke your consent.

#### You agree and consent to the following by signing this agreement:

- You consent to LCD MEDICAL PLLC providing Chronic Care Management services and or Remote Patient Monitoring to you and billing for them.
- You agree to your RPM devices a combined total of 16 times per month.
- You acknowledge that only one provider can furnish and bill for chronic care management services and or Remote Patient Monitoring for you during a calendar month. Please let us know if you have been asked to enter into a similar agreement with another practice.
- $\bullet \ \ You \ consent \ to \ electronic \ communications \ of \ your \ health \ information \ with \ others \ involved \ in \ your \ care.$
- You understand that standard coinsurance, copays, and deductibles apply to chronic care management services, so you will be billed for these services once a month and these are not face-to-face meetings with your provider.
